PERSONAL NARRATIVE:

I am a Professor of Medicine at the Stanford University School of Medicine and Professor of Organizational Behavior by courtesy at the Stanford Graduate School of Business. My research in the field of health care management and policy is informed by my interdisciplinary training in health policy, organizational behavior, and general management. Using innovative mixed methods and organizational theories, I study teams and organizations to understand how leaders and policymakers can improve the safety, quality, and value of health and health care delivery through changes in institutional culture, leadership, organizational design, and team dynamics. My research program is built around central challenges in health care delivery (ensuring patient safety despite enormous complexity and uncertainty in diagnosis, treatment, and disease progression; integrating increasingly fragmented services across multiple service providers and organizations; implementing, adapting, and sustaining technological innovations that enhance the value of health care; and creating a culture of health and well-being among sectors not traditionally considered part of the health ecosystem), where my research suggests that learning-and systems-oriented leaders and teams and supportive organizational cultures are critical factors for creating a high performing health care delivery system. My current research addresses critical

issues related to collaboration to promote health equity, technology-enabled future of work, and business sector's role in promoting employee, consumer, community, and environmental health and wellbeing.

A central feature of my research involves developing, and making freely available, survey instruments and observational tools that measure practitioner and patient perspectives on key interpersonal and organizational constructs. These tools generate novel information about critical features of organizational behavior, which I have used to conduct research that tests organizational theory and examines the effectiveness of delivery system innovations. One of my key strengths is my ability to collaboratively design and lead multiple interdisciplinary, action-oriented research programs that cut across departments, schools, universities, and organizational partners. I am currently Principal Investigator of a National Science Foundation project exploring the human-technology frontier for perfecting safety-critical work in ICU and surgical settings, a National Institutes of Health Bridge2ai Teaming Module charged with applying and advancing team science in support of the AI-READI data generation project, and Principal Investigator for Stanford's Program on Business and Public Health, supported by RWJF.

I currently teach two courses at Stanford's Graduate School of Business and School of Medicine, entitled: "Organizational Behavior in Health Care: Innovation and Collaboration in High Stakes Settings," and "Global Leaders and Innovators in Human and Planetary Health," and three undergraduate courses: "Upstreaming Health," in the d.school, Doerr Sustainability School, and Human Biology; "The American Health Care System and Health Policy" in Human Biology; and "Exploring Israel's Innovation and Entrepreneurship Ecosystem in Human and Planetary Health" through the Bing Overseas Study Program. Additionally, I teach the core course in organizational behavior for Stanford's Masters in Clinical Informatics and Management program, which I helped to create. I also teach in the Stanford PhD in Health Policy Seminar and in the School of Medicine Advance Course on Improvement Science. Previously, I developed and taught courses at the Harvard T.H. Chan School of Public Health, entitled "Health Care Organizations and Organizational Behavior" and "Leadership and Innovation in Health Care Organizations." I also taught in the Harvard PhD in Health Policy core course, guest lecture in Harvard Chan School MPH and executive education courses and conducted leadership training programs for the Brigham and Women's Hospital and the Massachusetts General Physician Organization. In addition, I serve or served as advisor or dissertation committee member for doctoral, masters, and undergraduate honors thesis students at the Stanford Graduate School of Business, Johns Hopkins School of Public Health, University of North Carolina, Virginia Commonwealth University, Harvard Chan School, Harvard Dental School, for postdoctoral fellows, and for junior faculty recipients of career development awards.

In addition to my research and teaching, I serve as Faculty Director of the Health Leadership, Organization, and Innovation Labs and Associate Director of the Clinical Excellence Research Center in Stanford's Division of Primary Care and Population Health. Additionally, I serve as Research Director of the University's Distinguished Careers Institute. I lead the Health Leadership, Organization, and Innovation Fellowship, which supports Stanford Medicine and Graduate School of Business students to collaborate with health care teams from Federally Qualified Health Centers transforming care processes through participation in the High Value Health Care Incubator. I am a member of Stanford University's Committee on Faculty and Staff

Human Resources, Executive Committee Member for Stanford's Forum on Women's Faculty, and Mentor to Stanford's Knight-Hennessy Scholars. I am affiliated faculty with Stanford Health Policy, Freeman Spogli Institute of International Studies, Center for Innovation in Global Health, Clinical Excellent Research Center, and Woods Institute for the Environment. While at Harvard, I served as Director of Graduate Studies for the Harvard PhD Program in Health Policy and Co-Chair of the PhD Program's Management Track, Field of Study Leader for the MPH in Health Management at the Harvard T.H. Chan School of Public Health, and member of the University Benefits Committee.

Outside the university, I currently serve as a member of the Lancet Committee Project on Transformative Research to Scale Mental Health Intervention and recently completed service on the National Academies of Science, Engineering and Medicine Committee on Transforming Health Care to Create Whole Health: Strategies to Assess, Scale, and Spread the Whole Person Approach to Health. In 2022, I completed a five-year leadership term, including Professional Development Chair, Program Chair, Vice Chair, Chair, and Past Chair for the Health Care Management Division for the Academy of Management, the preeminent professional association for management and organization scholars worldwide, including nearly 20,000 professors, students, and practitioners from over 120 countries. In continuing service to the AOM Health Care Management Division, I am currently a member of the Communications Committee. I also serve as Chair of the Advisory Board, for an AHRQ-sponsored R18 patient-safety learning lab: Closed Loop Diagnostics; and Board Member, Harvard Medical Faculty Physicians. Additionally, I serve as a Member of the National Steering Committee on Patient Safety, IHI/NPSF; Expert Advisory Board Member, Britain's Healthiest Workplace; Special Expert Panel Member, Leapfrog Safety Score, Leapfrog Group. I have served on editorial boards for leading journals, including: Health Services Research (2007-), Medical Care Research and Review (2015-), Journal of Hospital Management and Health Policy (2020-), BMJ Leader (2022-) and Health Care Management Review (2011-2017). I have served on 10 Technical Expert Panels, including two for CMS, AHRQ, two for VA, Lucian Leape Institute, CRICO, Betsy Lehman Center, MA Health Quality Partners, Bureau of Information New South Wales. I have published more than 250 articles in academic journals and books on healthcare management, health policy, and health system reform. My publications have won numerous awards, including Article of the Year 2022 from Medical Care Research and Review; best paper awards from the Academy of Management's Health Care Division in 2009, 2010, 2011, 2019, two in 2023; and the Most Influential Service Operations Paper of 2015-2016, Production and Operations Management Society College of Service Operations. I was the recipient of the 2013 Avedis Donabedian Healthcare Quality Award from the American Public Health Association for outstanding contributions in the field of quality assurance and improvement; the Lewis W. Blackman Patient Safety Champion Award, South Carolina Hospital Association 2013, for Safe Surgery South Carolina; Teaching Citation, Harvard Chan School 2014, for excellence in teaching; and the Sherman Award 2019, for excellence in patient engagement.

Previously, I was Professor of Health Care Management and Policy at the Harvard T. H. Chan School of Public Health and the Department of Medicine at Harvard Medical School in the

Mongan Institute for Health Policy, Massachusetts General Hospital. I acted as Director of Graduate Studies of the Harvard PhD in Health Policy Program (2016-2017) and Co-Chair of the Health Policy PhD Program's Management Track (2013-2017), Director of the Healthcare Management Field of Study for the Masters in Public Health Program at the Harvard Chan School (2015-2017), Implementation Research Director for the Safe Surgery 2015 initiative (2010-2017), and Member of the University Benefits Committee (2012-2017).
