### Policy Engagement

- **Brick Manufacturing in Bangladesh.** Air pollution generated by brick kilns in Bangladesh are estimated to result in over 6,000 premature adult deaths annually. We developed an intervention, Zigzag 2.0, which offered brick kiln owners and operators technical support and training to adopt low cost changes in kiln management and insulation. We deployed this intervention in a randomized controlled trial among 357 zigzag kilns in Khulna Division in the 2022/2023 brick kiln season. 65% of the kilns offered the intervention adopted the two most important components of the intervention. Kilns that adopted the intervention used 24% less coal per 100,000 bricks produced, generated 21% less carbon dioxide emissions and 21% lower PM2.5 emissions. After presenting these results to the Government of Bangladesh Ministry of Environment Forest and Climate Change, the Ministry changed their stance regarding non-engagement with the informal brick making sector. Following a formal invitation from the

Government of Bangladesh Ministry of Environment Forest and Climate Change we have worked with partners to provide technical support to convert more kilns to Zigzag 2.0. So far we have catalyzed the conversion of >500 brick kilns in Bangladesh. The reduction in carbon dioxide from adopting the Zigzag 2.0 intervention for a single year provides the equivalent carbon dioxide reduction as planting over 3.2 million tree seedlings and having them grow for 10 years. The Bangladesh National Air Quality Management Plan 2024-2030 now specifically calls for precisely the type of management and operational upgrades which we have pioneered and evaluated.

- **Lead in South Asia:** Lead is a particularly devastating toxin. It causes permanent cognitive deficits among exposed children and results in an estimated 5 million premature deaths from cardiovascular disease each year globally. Our earlier work identified adulteration of turmeric with lead chromate as a major unrecognized source of lead contamination across rural Bangladesh. We have worked with authorities in Bangladesh who have implemented interventions to discourage the practice of adding lead chromate as a colorant to turmeric. Prior to these efforts we found that 47% of turmeric samples from the major wholesale market in Dhaka were positive for lead. Our most recent follow-up finds 0% of samples in the wholesale market with detectable lead. We continue to broaden our work on lead contamination of turmeric into India and Pakistan. We have also found high levels of lead in numerous states across India and Pakistan. We continue to explore the supply chains to understand where the adulteration is taking place. We've had several rounds of conversations with food safety authorities in Bihar State in India, where the level of contamination is highest working to encourage steps to reduce contamination using an approach that was successful in Bangladesh. These conversations are ongoing. We are also reaching out to stakeholders in other affected states across India and Pakistan.

We also completed an attribution study in Dhaka, Bangladesh where we found that living near industries that melt lead is the dominant risk factor for elevated blood lead levels. We have engaged with the Ministry of the Environment to support developing a focused and sound strategy to address these exposures.

### **Policy Engagement**

- Findings from the Human Trafficking Data Lab’s project with implementing partner Centro de Defesa da Vida e dos Direitos Humano / Carmen Bascarán (CDVDH/CB) led the organization to adopt a practice of participating directly in task forces to ensure point-of-rescue contact with survivors and immediate survivor connection to services. Furthermore, through collaboration with Brazil’s Federal Labor Prosecution Office, the Lab secured punitive-damages funding to support the acquisition of a vehicle for CDVDH/CB to broaden the reach of their active searches, particularly in remote areas.
- The Lab facilitated a formal agreement between the Ministry of Human Rights (SEDHIPOP) in Maranhão, Brazil and CDVDH/CB to gain wider access to the national case management system containing information about trafficking survivors. Access to this system is a necessary part of the process by which partners can speed the process of assisting survivors.
- The Lab presented the findings of a peer counseling project funded by Innovations for Poverty Action (IPA) Human Trafficking Research Initiative (HTRI) to IPA as well as to the U.S. Department of State (USDOS) Trafficking in Persons Office to Monitor and Combat Trafficking in Persons.
- With funding from the Lab, implementing partner Ori Consultoria in Brazil led trainings for close to 500 social workers, government officials, and civil society representatives across multiple municipalities on the implementation of the National Flow of Assistance to Victims of human trafficking and slave labor, effective use of the Integra Victim Case Management System, and best practices for survivor-centered assistance.
- The Lab presented our work developing and implementing a remote detection tool (ChAR) targeting forced labor and deforestation in the Brazilian state of Maranhão at the Tech Against Trafficking Summit at Microsoft Headquarters in Redmond, WA. The Summit was attended by several policymakers from across the US Government, as well as dignitaries such as Baroness Theresa May and former USDOS Trafficking in Persons Ambassador-at-Large John Cotton Richmond.
- A Lab representative moderated a panel on legal strategies to combat human trafficking at the University of Michigan Law School, featuring pathbreaking anti-trafficking

advocates Martina Vandenberg of the Human Trafficking Legal Center, Jane Khodarkovsky of Arktouros PLLC, and Agnieszka Fryszman of Cohen Milstein. Several current and former US Government representatives were in attendance alongside academics and CSOs.

- The Lab presented at a quarterly meeting of the Monitoring and Evaluation of Trafficking in Persons (METIP) working group on the subject of novel data sources, namely how administrative and geospatial data can be used in human trafficking research. Several government representatives focused on national anti-trafficking efforts were in attendance.
- The Lab will be represented among a small group of select researchers and government policymakers convening December 2-4 in New York to set global research priorities for addressing human trafficking and forced labor through a joint International Labour Organization and IPA HTRI initiative.
