Background

As of January 1, 2021, a new Federal Government policy required hospitals in the US to publicly release information about prices for their services. Hospitals are required to provide "clear, accessible pricing information about the items and services they provide" in two ways. First, they must provide a machine-readable file that includes information including both gross charges and payer-specific negotiated amounts for all of the services that could be provided by the hospital on an inpatient or outpatient basis. Second, they must provide a "display of shoppable services in a consumer-friendly format." This is intended to include prices for all 70 CMS-specified shoppable services, and prices for a minimum of 300 total shoppable services that can be scheduled by a healthcare consumer in advance. (Hospitals have discretion in choosing the minimum 230 additional procedures they will include.) Hospitals can meet this second requirement by posting a machine-readable file of prices, or by providing a price estimator tool that would allow a consumer to enter information and obtain an individualized estimate of their out-of-pocket costs.

Enforcement of this requirement is overseen by CMS, which is required to monitor hospital compliance. CMS may require hospitals it deems non-compliant to establish corrective action plans and may publicly identify non-compliant hospitals. It may also impose monetary penalties of up to \$300 per day of noncompliance. That is, a hospital deemed non-compliant

for a year and assessed the maximum monetary penalty for the entire time would face a penalty of \$109,500 (\$300/day * 365 days).

The new regulation has the potential to improve price transparency. Despite a large amount of interest, and a number of state-level efforts, information about prices for hospitals services has been difficult to obtain. Perhaps the easiest to obtain has been information about hospital "list," or "chargemaster," prices, and those are often difficult to interpret due to lack of standardization and inconsistencies between hospitals. While this may be valuable in some situations, chargemaster prices are often not a good indication of the "allowed amounts" that have been negotiated with insurers for services, which may be the most applicable for many consumers and policy purposes. Rates negotiated with insurers are often considered confidential and have been much more difficult to determine.

California could potentially benefit from the new regulation. Since 2006, state-licensed hospitals have been required to submit chargemaster information to the state Office of Statewide Health Planning and Development (OSHPD), which makes the information available on the web.⁶ Hospitals are also required to submit a list of average charges for 25 common outpatient procedures. However, data on allowed amounts and negotiated prices has been difficult to access in California as in other parts of the country.

Improving hospital price transparency may improve the functioning of health care markets. Optimistically, some analysts have examined issues related to price transparency, often cite a lack of transparency as a reason for high health care spending, and in some settings have related more transparency with lower or more uniform prices. At the same time, whether or not this policy will lead to benefits remains the subject of much discussion.

Observers have pointed out that if price information is not sufficiently clear, comparable, or accessible then potential benefits of the policy may be missed, and have noted the potential for unintended unhelpful consequences. Nonetheless, proponents of the new policy cite their expectation that promoting transparency will enable consumers to be more active, increasing pressure to provide lower prices and better quality, and ultimately leading to more affordable health care and lower healthcare coverage costs.

If California hospitals comply with the new price transparency policy, it could improve price transparency in California. The extent of compliance by California hospitals is not currently known. Several recent reports suggest that compliance nationwide has been far from complete. This study was conducted to assess the rate of compliance of California hospitals with the regulations, as of April 2021.

Methodology

Sample selection

All institutions licensed as hospitals in the State of California were included in our analysis, since the new regulation is written to apply to all institutions licensed as a hospital under state or local law. We obtained a list of all 2021 California-licensed hospitals from the California Office of Statewide Health Planning and Development (OSHPD) Current California Healthcare Facility Listing. The list contained 522 hospitals with active licenses, of which 445 were hospitals with a "general acute care" license type, including children's hospitals, specialty hospitals, and some other types of institutions (e.g. skilled nursing facilities), and 77 were behavioral health facilities with one of three license types: "acute psychiatric hospital",

"psychiatric health facility", or "chemical dependency recovery hospital".¹³ We conduct initial analyses on all 522 of these facilities.

Although the regulation states that all facilities with a license type of hospital are required to comply, we noted that some hospitals in the OSHPD-licensed list are likely to operate substantially differently than most hospitals with the "general acute care" license type, which may affect compliance patterns. These facilities include behavioral health facilities, skilled nursing facilities (SNFs), Kaiser hospitals, and California state hospitals. Thus, in addition to our initial analysis on all 522 hospitals, we conducted a second analysis on just the subset of 391 general acute care hospitals that included only non-Kaiser and non-state-owned general acute care, children's hospitals, and specialty hospitals. We also conducted separate analyses on other hospital subgroups including SNFs, behavioral health facilities, Kaiser-owned and operated hospitals, and California state-owned and operated hospitals. We identified Kaiser hospitals as hospitals including "Kaiser" in their name, or that listed a kaiserpermanente.org web address. We identified California state hospitals by verifying their existence on the CA Department of State Hospitals website, dsh.ca.gov. We identified SNFs as facilities with an OSHPD ID beginning with the number 2 as specified by the California Building Code. 14 The list of 522 hospitals, including name, OSHPD license category, and the categorization of the hospital for study analyses, is included in the Appendix 1.

Search strategy

For each hospital, we searched the internet for the hospital's website using the hospital's name and address as stated in the OSHPD listing. Between April 1, 2021 and April 30, 2021, we examined the websites, seeking to identify information compliant with the price transparency regulations. This information included files for chargemasters, standard charges, shoppable services, and links to online price estimate tools and would usually be found in the "Patients" or a similar tab where patients can find more information related to billing, insurance, and financial assistance. Some hospitals had specific tabs labeled "Price Transparency." If files were not identified within these sections, we searched within the website for keywords such as "chargemaster", "standard charges", "price transparency", or similar phrases, using the website's built-in search function or via Google search restricting to the hospital's domain using the "site:" filter.

Some reports have noted that hospitals may be embedding codes in their website that prevent search engines from displaying pages related to their pricing.¹⁵ In many cases, our search did not rely on search engines to identify relevant files, but it is possible our method would not have been able to find pricing files in some cases.

Compliance measures

For each hospital, we coded a number of indicators of compliance, based on the requirements of the regulation. Figure 1 denotes the key measurable requirements of the

regulation on which we focused. For each hospital examined, we coded the following measures of compliance with the first ("standard charge") component of the regulation 17: (1) whether the hospital provides any downloadable machine-readable file in Excel, JSON, XML, or CSV format with any standard charge information; (2) whether the machine-readable file includes gross charges; (3) whether the machine-readable file includes discounted cash prices – for example those that might be offered to patients qualifying for discount programs; 4) whether the machine-readable file includes the de-identified minimum and maximum negotiated rates across payers with which the hospital contracts; and (5) whether the machine-readable file includes payer-specific negotiated rates for at least one identified payer and plan. For hospitals that reported payer-specific negotiated rates for at least one payer, we also took note of the number of payers for which each hospital reported negotiated rates as well as whether hospitals included at least one plan from each of the nine largest insurers in California by enrollment. 18

We coded the following measures of compliance with the shoppable services component of the regulation¹⁹: 1) whether the hospital provided a shoppable services machine-readable file; 2) whether the hospital provided a shoppable services online tool; and 3) for those that did provide a tool, whether the tool could be used without account registration or disclosure of personal identifying information (PII).




Figure 1. Key measurable requirements of 45 CFR § 180.50 ("Requirements for making public hospital standard charges for all items and services") and 45 CFR § 180.60 ("Requirements for displaying shoppable services in a consumer-friendly manner") that we focus on in our analysis. All licensed hospitals are required to post 1) a machine-readable file that includes a description of each item or service provided by the hospital in both inpatient and outpatient settings, any code used by the hospital for purposes of accounting or billing for the item or service (such as CPT code), and five types of standard charges that apply to each item or service: the gross charge, payer-specific negotiated charge (clearly associated with the name of the third-party payer and plan), de-identified minimum charge, de-identified maximum charge, and discounted cash price; and 2) a consumer-friendly file or online price estimate tool with a plain-language description and the five types of standard charges listed above for at least 300 shoppable services, 70 of which must be from the CMS-specified list of shoppable services if offered by the hospital. If multiple hospitals operate under a single license but have different standard charges, they must separately make public the standard charges applicable to that location. The hospital must also display the location at which each shoppable service is provided in the consumer-facing file/tool. Source: https://www.law.cornell.edu/cfr/text/45/180.50

From these measures, we constructed an overall measure of whether the hospital appeared to be compliant with the regulation. Hospitals were classified as fully compliant if they provided a downloadable machine-readable file with all five types of charges and at least one identified payer and plan as well as either a shoppable services file or tool that was

accessible without requiring a login or PII. Hospitals were classified as partially compliant if they posted at least a downloadable machine-readable file that was clearly distinct from a chargemaster, a shoppable services file, or shoppable services tool. Hospitals were classified as noncompliant if we were unable to find any of those three items.

The standard charge component of the regulation does not specify a minimum list of items or services to include. However, the shoppable services component requires at least 300 shoppable services to be listed, 70 of which must be from the CMS-specified list of shoppable services (and an indicator if any services in the CMS list are not offered by the hospital). Due to time constraints and heterogeneity of shoppable services data formats (including online shoppable services tool formats that make it technically difficult to determine the full list of shoppable services within the tool), we did not assess whether hospitals included the requisite 300 shoppable services. We also did not verify whether hospitals providing outpatient services included services provided in the outpatient setting in addition to inpatient services in their standard charges file.

Hospital area characteristics

To better understand whether hospital compliance is associated with area demographic factors, we merged our dataset with county-level data on poverty and uninsurance rates from the 2018-2019 release of the Area Health Resources File. 20 We categorized hospitals according to whether their county poverty and uninsured rates were above or below the sample median. We were also able to obtain hospital-level data on hospital characteristics for 432 of the 522

hospitals in our OSHPD list (83%) from OSHPD's 2019 Hospital Annual Financial Data, including size based on number of licensed hospital beds, teaching status, rural status, and net patient revenue per patient-day. For analysis according to hospital bed size, we placed hospitals in three groups (<100 beds, 100-499 beds, >500 beds). For analysis according to net patient revenue per patient day, we categorized hospitals according to quartiles of the observed distribution. Hospitals that were included in the financial data file, and thus in this analysis, did not appear to be significantly different in terms of compliance status from those for which data from the Annual Financial Data could not be merged and were therefore excluded (see Appendix 2).

Using these data, we tabulated rates of full, partial, and non-compliance according to hospital characteristics. We conducted this analysis for all 432 matched hospitals, and also for the subset of the 391 general acute care, children's, and specialty hospitals that could be matched (N=329).

Turquoise data comparison

We also obtained data from Turquoise Health, which has compiled data on prices reported by hospitals around the country.²¹ Turquoise health reports a measure of compliance with the new regulations. Their compliance score ranges from 1 (no machine-readable file is present and provider may or may not post a shoppable service tool or file) to 5 (provider posts a machine readable file including negotiated rates and cash prices, plus a shoppable services

tool or file). Turquoise assesses compliance using a combination of machine learning algorithms and manual review.

We compared the data we obtained from websites to the Turquoise data, matching hospitals by OSHPD ID or hospital name. As of April 4, 2021, Turquoise had 455 California hospitals in their database, of which we were able to merge 418 to the data we obtained from hospital websites. Turquoise data included hospitals that are not listed on OSHPD's facility list. These include Veterans Affairs (VA) hospitals, military treatment facilities, and correctional health care facilities. The Turquoise data also contained three hospitals that had closed. These facilities were not included in the OSHPD list, and are not included in our analysis. We used this comparison to cross-check information we identified from hospital web-sites.

Results

Analysis of All 522 California Hospital-Licensed Facilities

Our initial analyses include all 522 licensed facilities in the OSHPD list. We first assessed compliance with the standard charges component of the regulation. Of the study hospitals, 276 of 522 hospitals (53%) posted a machine-readable file of standard charges available in CSV,

Excel, XML, or JSON format (Figure 2).²³ Hospital machine-readable files varied in the types of standard charges included. 269 hospitals (52%) posted a machine-readable file with gross charges, 207 (40%) posted a machine-readable file with discounted cash prices, 199 (38%) posted a machine-readable file with de-identified minimum and maximum negotiated prices, and 194 (37%) posted a machine-readable file with payer-specific negotiated prices. 141 hospitals (27%) appeared to be fully compliant with the standard charge component of the regulation, posting a file with all five types of charges required to be made public by the regulation: gross charge, discounted cash price, payer-specific negotiated charge with identifiable plans, de-identified minimum negotiated charge, and de-identified maximum negotiated charge.


Of the hospitals that included insurers²⁴, the average number of insurers included was 27 (s.d. 27.1, range 1 to 229, median 21). Of hospitals including insurers, the most commonly included plans were Blue Shield (60% of hospitals that included identifiable insurers), followed by Aetna (58%), Cigna (51%), and Health Net (50%). A more detailed breakdown of types of charges included by partially compliant hospitals is shown in Appendix 3.



We next considered compliance with the shoppable services component of the regulation. Of the 522 hospitals, 311 (60%) posted a shoppable services file or tool, with 127 posting a shoppable services machine-readable file and 260 posting an online price estimate tool (76 posted both a file and a tool). Of hospitals posting a tool, 214 (82%) made their tool accessible without requiring account registration, login, or disclosure of PII. Thus, 296 hospitals (57%) appeared to be fully compliant with the shoppable services component of the regulation, posting either a file or accessible tool (Figure 3).

Figure 3. Hospital compliance with shoppable services component




Overall, according to our criteria, 126 of the 522 hospitals (24%) were fully compliant with both the standard charges and shoppable services components of the new price transparency regulation. 226 (43%) were partially compliant, posting at least a downloadable machine-readable file of standard charges that was clearly distinct from a chargemaster, shoppable services file, or shoppable services tool (including 109 hospitals that posted both a standard charges file and shoppable services file or tool, but either or both components did not include all of the required information). 170 hospitals (33%) were noncompliant and had not posted a file of standard charges, shoppable services file, or shoppable services tool.

Analysis of subset of 391 general acute care, specialty, and children's hospitals


After excluding behavioral health facilities, SNFs, Kaiser hospitals, and California state hospitals, we found that a slightly higher proportion of the remaining 391 general acute care, specialty, and children's hospitals were fully compliant relative to the rate of compliance amongst all hospitals. 221 of the 391 hospitals (57%) had posted a machine-readable file of standard charges. 214 (55%) posted a machine-readable file including gross charges, 161 (41%) posted a machine-readable file with discounted cash prices, 180 (46%) posted a machine-readable file with de-identified minimum and maximum negotiated prices, and 177 (45%) posted a machine-readable file with payer-specific negotiated prices. 132 (34%) appeared to be fully compliant with the standard charge component of the regulation, in contrast to 27% of all 522 hospitals.

251 (64%) of the 391 hospitals had posted a shoppable services file or tool, of which 82 (21%) posted a shoppable services machine-readable file and 209 (53%) posted an online price estimate tool. Of the hospitals posting a tool, 200 (96%) made their tool accessible to anyone and did not require account registration or disclosure of PII. 242 (62%) of hospitals appeared to be fully compliant with the shoppable services component of the regulation. Relative to all 522 hospitals, the subset of 391 general acute care, specialty, and children's hospitals had slightly higher full compliance (62% vs 57%) and were more likely to post an accessible online price estimate tool than a file.

Overall, 117 of the 391 general acute care, specialty, and children's hospitals (30%) were fully compliant according to our definition, 170 (43%) were partially compliant, and 104 (27%) were noncompliant.

Compliance Rates for Different Types of Hospital-Licensed Facilities




Figure 6. Compliance for all 522 hospitals and by subgroup

Figure 6 compares the rates of full, partial, and non-compliance across all of the different categories of hospitals that we distinguish within the full sample of 522 hospitals.

Rates of full compliance are highest for the general acute care, children's, and specialty hospitals. In contrast, only 9% (N=7/77) of hospital-licensed facilities designated as behavioral

health facilities, and 13% of hospital-licensed facilities designated as SNFs (2/16) were fully compliant. It is important to note that we only studied behavioral health facilities and SNFs with California hospital licenses, which will not include all such entities in the state. We found nearly all of the Kaiser hospitals to be partially compliant, but also note that their contracting and billing structure is likely different from that of other hospitals and compliance measures applicable in other settings may not be fully appropriate to apply to them. In results not shown, 0% (0/6) of California state hospitals were fully compliant. As in the case of Kaiser hospitals, their contracting and billing structure is likely quite different from other hospitals and compliance metrics used here may not be fully appropriate.

Characteristics of compliant vs noncompliant hospitals

We examined whether compliance rates varied according to hospital characteristics, first using the 432 hospitals for which we could match facility level characteristics from OSHPD and area-level data from the AHRF. At the hospital level, smaller hospitals were more likely to be noncompliant, whereas larger hospitals were more likely to be partially compliant. Hospitals in the lowest quartile of net patient revenue per patient-day were more likely to be noncompliant, whereas hospitals in the top quartile of revenue per patient-day were more

likely to be partially compliant. Rural hospitals were more likely to be noncompliant than partially or fully compliant. Teaching hospitals were more likely to be partially compliant.

Hospitals located in counties with higher average percent uninsured and poverty rate were less likely to be fully compliant.

We repeated this analysis using the subset of the 391 general acute care, children's, and specialty hospitals for which we could merge data from the Hospital Financial Data files

(N=329). Results are shown in Table 2. Results are similar to those in Table 1, with the exception that there is no longer a statistically significant difference according to net patient revenue per patient day.

Discussion

Compliance with 45 CFR §180

As of April, 2021, only 30% of all California hospital-licensed general acute care, children's, and specialty facilities were fully compliant with new Federal regulations requiring hospitals to report pricing data. Among all California hospital-licensed facilities, the rate of full compliance was 24%. This low level of compliance is consistent with reports of limited compliance in other groups of hospitals around the United States. Somewhat higher rates of compliance, though still far from complete, were observed with specific subparts of the regulation, including providing a resource for finding prices of shoppable services (compliance rate 64% in general acute care, children's, and specialty hospitals) or providing a machine-readable file with payer-specific negotiated rates (compliance rate 45%).

Nearly half of hospitals were partially compliant, indicating awareness of the price transparency regulation but incomplete compliance with it. There are a variety of components with which hospitals could fail to comply. Many hospitals posted a file that included at least their "gross charges" but left out other required components. A common omission was prices specific to individual payers. For example, some hospitals included de-identified payer-specific rates but did not disclose names of insurers or plans. As another example, one hospital posted a file with a list of services and names of health plans but nearly every cell in the file listed the payer-specific negotiated rates all had the value of "Variable" rather than numeric values. For the shoppable services portion of the regulation, some hospitals posting an on-line tool had created barriers to using the tool (e.g., requiring a login or disclosure of PII) despite explicit warning not to do so in the regulation. Other hospitals are using third-party platforms to host

their pricing data, such as hospitalpriceindex.com and cdmpricing.com, and in several cases these platforms did not correctly display the information from the hospital's JSON file. It is unclear whether this issue is due to an unforeseen problem with the third-party software or lack of information in the hospital JSON file.

Reasons hospitals are not fully compliant are not known. It is possible that some hospitals may be intending to comply, but may take time to work out the requirements which are extensive and unprecedented. It is possible that some hospitals may not be fully aware of the requirements. It is also possible that some hospitals may not want to disclose contract-negotiated rates that were previously considered proprietary information and may be willing to incur penalties that may be assessed for not doing so. Hospitals may have been waiting to see if CMS would enforce the regulation. The agency began issuing warning letters to hospitals on May 5, 2021, which may improve compliance rates over time. Hospitals identified by CMS as non-compliant will have 90 days to submit corrective action plans that address the issues before daily penalties are incurred. Overall, it remains uncertain how much, and how quickly, compliance might improve.

We noted that several of the facilities with licenses that suggest they are covered by the regulation but were deemed noncompliant were SNFs, behavioral health facilities, and state hospitals. These types of facilities may face different issues with compliance than general acute care, children's, and specialty hospitals. Some hospital representatives we spoke with from these facilities remarked that they did not post standard charges as they mostly serve Medi-Cal patients with free or low co-pay, or are a nonprofit facility that does not charge people based

on cost, suggesting that these hospitals may expect that atypical reimbursement or contracting practices affect their need to comply. In our analysis specific to general acute care, children's, and specialty hospitals, we found that compliance rates were somewhat higher.

It is possible that hospital resources are associated with compliance. For example, hospitals in counties with higher poverty and unemployment rates were less likely to be compliant. On the other hand, the largest hospitals were also less likely than smaller hospitals to be fully compliant.

Relevance

A motivating idea behind the regulation is that a lack of price transparency contributes to the upward trajectory in US healthcare spending and that greater transparency could aid efforts to lower healthcare spending. Whether and how the regulation could accomplish this remains a subject of debate. One possible avenue by which price transparency could affect spending is by increasing information available to consumers, who may use it in shopping for services, rewarding hospitals that have more competitive prices with additional business. However, there are some potential barriers to this happening. For this to work, the information provided by hospitals would have to be accessible, comparable, and interpretable by consumers, and it is not clear that this is now the case. Even when posted, standard price or shoppable services files are not all easy to obtain or use, and services are not always listed in

comparable ways across hospitals.²⁸ Additionally, patients who have limited choices of providers, or who seek care at times when shopping is difficult (e.g. medical emergencies), may not be able to use the data effectively. While price transparency may be of value to some consumers, these factors seem likely to limit the impacts the regulation can have through this channel.

Greater transparency could also affect costs if it influences contract negotiations between insurers and hospitals. This may offer more promise for contributing to cost containment, since hospitals, payers, and outside observers like news organizations that could publicly report on hospital prices may be both aware of the data and able to process and use them. Even in this case, though, a lack of consistency in the data across hospitals and complexity in using the data could limit its impact. And, as some observers have noted, it is unclear whether additional disclosure of prices will tend to reduce prices at the most expensive hospitals or increase prices at hospitals with initially lower prices.

In our review, we noted that a likely challenge to the effectiveness of the regulation is variation in the specific contents of files when hospitals do comply. The regulation allows for a variety of file types and shoppable services formats, which are likely to reduce administrative burden on hospitals with different operating systems and procedures. At the same time, this makes the resulting data less useful. Ultimately, standardization of procedure names, codes, and file formats across all hospitals seems valuable if the reported data is to be of service to consumers, hospitals and insurers.

Ultimately, it is hard to argue against additional price transparency, although with limited compliance and uncertainty about how the data disclosed could be used, it appears that a considerable amount of additional work will be required to achieve the goals of the new regulation.

Appendix 5: Comparison to Turquoise Data

At the time of this publication, Turquoise Health had published compliance scores for 210 of the CA hospitals in the OSHPD list. Turquoise had deemed that 113 (54%) of these hospitals were fully compliant, which was substantially higher than our full compliance rate based on manual review of 24%. Among the 210 hospitals with a Turquoise compliance score, we find that 72 (34%) are compliant based on our manual review. Hospitals marked fully compliant in our manual review were more likely to have a higher Turquoise compliance score (51% of hospitals with a compliance score of 5 vs 7% of hospitals with a compliance score of 1), and hospitals marked fully noncompliant in our manual review were more likely to have a lower Turquoise compliance score (81% of hospitals with a compliance score of 1 vs 3% of hospitals with a compliance score of 5) (p<0.001, see Appendix Table A7).

Turquoise compliance score frequency.

Turquoise Health assigns hospitals a compliance score using the following criteria: A compliance score of 5 indicates that provider posted a shoppable services tool or file as well as a machine readable file with negotiated rates, discounted cash prices, and names of commercial plans, equivalent to our "fully compliant" determination in our manual review process. A compliance score of 4 indicates that the provider posts a shoppable service tool + the machine readable file is present but missing a key element (such as, codes, key services the provider is known to offer, or cash rates). A compliance score of 3 indicates provider posts a shoppable service tool + multiple key elements listed above are missing. However, meaningful commercial rates and cash rates are still listed. A compliance score of 2 indicates provider posts a shoppable service tool + a machine readable file with cash rates, Medicare Advantage or Managed Medicaid rates only. Or, the machine readable file is not available for download as required by the rule. A compliance score of 1 indicates provider may or may not post a shoppable service tool + no machine readable file is present (equivalent of noncompliant in our manual review).
