# Work-in-Progress

Presidents versus the Press: Media Freedom and Democratic Accountability in Latin America, book manuscript in progress (with Elizabeth A. Stein)

This book explains the contentious relationships between presidents and the press in democratic Latin America. Normative and empirical democratic theory identifies an important role for the media in democratic accountability. Yet, the media only can perform this job when they can work safely, freely and independently from government. Here in lies a deficit of accountability trap: the media's vulnerability to government infringements on their freedom increases as the quality of horizontal accountability declines. Where legislatures and judiciaries hold weak powers relative to executives, they cannot adequately constrain presidents from taking actions against the media. Our theorizing of this trap leads to our president-centered explanation for media freedom decline in Latin America. Empirically, we focus on Latin America's "left-turn," the period that followed Hugo Chavez' election as president of Venezuela. Employing a nested analysis research design, we support our argument using quantitative cross-national analysis of Freedom House's Press Freedom Index from 1996-2015 and we examine the causal mechanism and un-pack the press freedom scores using comparative case studies of several presidencies in Argentina, Bolivia, Brazil, Chile, Colombia and El Salvador.

"Dying in Darkness: The Dynamic Relationship between Media Freedom and Democratic Backsliding" (with Elizabeth A. Stein)

This paper examines how declines in media freedom contribute to the process of democratic backsliding. Our argument differs from a tautological claim that restricting the media implies a decline in democracy simply because democracy by definition includes free media. While we accept this definition, our claim here is that illiberal leaders purposefully rein in freedom of the press as a proactive strategy to concentrate power in the executive branch and as a preemptive strategy to weaken accountability actors who might try to prevent their power grab. To model the process of democratic backsliding, we employ a dynamic panel-data analysis to time-series, cross-sectional dataset covering the period from 1996 to 2016. In particular, we show that declines in press freedom precede increases in electoral manipulation and decreases in institutional checks on executive power. Our results further indicate that changes in media freedom have lasting effects on democratic accountability over the long-run.

"What Causes Democratic Backsliding: Populism or Dominant Executives?" (with Antonio Benasaglio Berlucchi)

This project examines the causes of democratic backsliding in a quantitative analysis using time-series, cross-sectional data. Studies of democratic backsliding often focuses on the infamous cases of decline that make front-page news, yet we lack systematic analysis of the full range of potential cases that would allow us to distinguish leadership- and ideology-centered arguments from institutional and structural arguments. With this goal in mind, we compare the effect of populists and dominant executives on democratic backsliding, while using a global dataset of executives elected in democracies and applying matching methods to our panel data to improve the validity of causal inference.
